



### **Notice to Bidders**

### TOWN OF INUVIK

Bid for:	Hidden Lake Steel Reservoir Tank Rehabilitation.

Sealed envelopes containing Bids clearly marked "Hidden Lake Steel Reservoir Tank Rehabilitation" and addressed to <u>Town of Inuvik, Town Office, 2 Firth Street, P.O. Box 1160, Inuvik, NWT, X0E 0T0</u> shall be received at the offices of <u>the Town of Inuvik Defore 2:00:00 p.m.</u>, local time, on August 5, 2016.

### The Work generally comprises:

- .1 The following is an approximate description of the Work to be completed under this Contract. Supply all labour, materials and equipment necessary for the repair, re-coating and recommissioning of the steel water tank project. The work of the project includes, but is not limited to, the following (quantities and measurements being approximate and rounded):
  - .1 Removal of existing coal-tar lining to the interior (roof, wall, floor and internal piping connections) of steel water storage tank 74H843H01. Storage tank is 15.545m internal diameter, 12.19m high to edge of roof. Roof is domed.
  - .2 Allow tank bottom to be inspected to confirm existing corrosion pits and locate any new pits with corrosion depths equal or greater than 60% (5.7mm). Locate any corroded seam welds.
  - .3 Existing internal piping, to be removed and replaced with new.
  - .4 Patch wall and floor corrosion pits, grind and repair any corroded weld seams.
  - .5 Apply two coat of Tnemec to the interior of the tank (roof, wall, floor and internal piping).
  - .6 Sanitize tank and piping.
  - .7 Provide hydrostatic test of tank and piping.
  - .8 Provision of temporary facilities to maintain piped delivery of water services throughout the project area during tank rehabilitation work.
  - .9 All other work as detailed in the specifications and shown on the Contract Drawings.
